

Hostel

AUD has 45 seats for women in its hostel in Kashmir Gate. The students will need to make their own travel arrangement from Hostel to AUD Karampura Campus.

Admissions

Seats: 32 per vocational programme

Minimum Eligibility

Class 10+2 pass from CBSE or its equivalent from recognised board or university

Selection Procedure

Stage-I:

On the basis of Class 12 marks (points) + Points awarded for vocational Subject + Marks secured in Vocational Aptitude Test (VAT). Short listed candidates will be called for an interview.

Stage-II:

Offer of admission will be based on the cumulative score on all the 4 criteria of Class 10+2 marks, points awarded for vocational subject in class 10+2, marks secured in VAT and the interview points.

Weightage during admission will be given in the following:

- 40% weightage class 10+2 marks
- 10% weightage to vocational subject in class 10+2 (CBSE recognised vocational subjects)
- 25% Vocational Aptitude Test
- 25% weightage for Personal Interview

FEE Structure

- In SVS tuition fee will be charged @ Rs.750/- per credit. Therefore, in Semester 1 which has 30 credits the total fee towards tuition fee will be Rs. 22,500/-.
- Additional programme enrichment fees will be charged @ of Rs. 1000/- per semester. This is towards industry exposure, special seminars and interactions with industry experts.
- Student Welfare Fund Rs.500/- per semester.
- Caution/Security Money of Rs.5000/- refundable on completion of the programme.
