
The Students who are being provisional offered admission are requested to submit the following documents at the time of admission.


1. One passport size photograph

5. Migration Certificate
6. Reservation Category/ Caste Certificate (where applicable). Only OBC non creamy layer certificates issued by the Competent Authority of NCT of Delhi within the current year (2018) will be accepted.
7. Anti- ragging Affidavit. Two Affidavits on a Rs. 10/- non -- judicial stamp paper each -- one by student and another by Guardian/Parents against ragging. (The formats are available on the website: <http://aud.ac.in/admissions2018>)


