The list is **provisional** and final admission will be subject to verification of marks and other requisite documents at the time of admission. Offer may be withdrawn in case it is found that any information provided is not authentic.

Candidates can take admission from 17th & 18th July, 2019 from 10:00 AM to 4:00 PM on both the days, failing which their seats will be allocated to the next candidate in the merit list according to the available seat(s) and category. No admission / queries will be entertained after the last date is over.

Candidate eligible for admission in more than one programme can only take admission in one programme.

The Students who are being provisionally offered admission are requested to submit the following original documents at the time of admission. They also need to submit a self-attested photocopy of each of the document at the time of admission.

1. One passport size photograph
2. Aadhar Card
3. Online Application Form
4. Domicile certificate / Address proof
5. Class 10th certificate for Date of Birth proof
6. Class 10th and 12th Mark sheet and passing certificate /Provisional Certificate (12th)
7. Migration Certificate
8. Reservation Category/ Caste/Tribe Certificate (where applicable). Only OBC non creamy layer certificates issued by the Competent Authority of NCT of Delhi will be accepted.
9. Candidates who have applied through Economically Weaker Section (EWS) category must bring their certificate issued by the Competent Authority of NCT of Delhi.
10. Anti- ragging Affidavit. Two Affidavits on a Rs. 10/- non – judicial stamp paper each – one by student and another by Guardian/Parents against ragging. (The formats are available on the website: <http://aud.ac.in/admissions2019>)

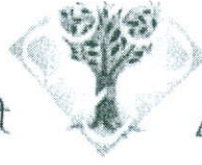
