16. Applicant availing seats under CW/Defence/Differently Abled Person (PwBD)/Single Girl Child/Kashmiri Migrant/CCA/Sports have to carry relevant documents/certificate issued by competent authority. Please refer Annexure of Admission brochure for more details.
17. Latest income certificate for availing fee waiver as per University policy.

Note: - The name of the applicant on the certificates claiming reservation must match with the applicant's name in their corresponding qualifying certificates and in CUET (UG)-2022. Similarly, parents' name should also match in the certificates. No undertaking on behalf of incomplete/invalid/non availability of document/certificate will be accepted at the time of applying.

**General Instructions:**

The applicants whose names are given in the provisional list as below in the order of merit are hereby called for document verification for the session 2022-23. The merit (System Based) has been calculated on normalised CUET Score on the basis of Languages/Subjects considered by the University for the programme and eligibility as detailed on the website <https://aud.ac.in/uploads/4/admission/admission-2022/ug/undergraduate-programmes-with-eligibility.pdf>. The class XII marks will be verified for the basic eligibility for the programme before provisionally admitting the applicant.

Note:

1. The list is provisional as prepared on the basis of the normalised CUET scores received from the National Testing Agency and application form submitted online on the University website by the applicants.
2. **Calling of the applicants for document verification shall not be construed as entitlement for admission. Greater numbers of applicants than the seats available have been called to ensure that seats do not remain vacant. In case, an applicant fails to produce the requisite documents within stipulated time limit of relevant merit list as detailed on page no.-1, the seat will be offered to the next applicant in the merit list as per his/ her eligible category.**
3. Applicants called as per the merit list, who fail to visit the campus for physical document verification with the requisite documents within the prescribed time limit as mentioned on p.no-1 will not be considered in the subsequent list. However, they may be considered in the spot round/special drive, if seats are vacant.
4. The applicants are shortlisted only once as per order of their merit and will not be shortlisted subsequently in the **same programme** in any other category or sub-category.
5. The applicant will be admitted to the programme on the basis of the merit list prepared taking into consideration the normalised CUET Scores on the basis of Languages/Subjects considered by the University for the programme and eligibility criteria and availability of seats in each programme.
6. Applicants in their own interest who have uploaded reservation certificates for availing reservation benefits (SC/ST/OBC/Defence/EWS/SGC/KM/PwBD) at the time of registration at University portal are requested to check the Admission brochure 2022-23 uploaded on the website for ascertaining the category to be considered as per the reservation policy.

**Admissions under Reserved Category:**

Clarification for Admissions under Reserved Category: Admission will be permissible to qualified applicants in any programme in the following conditions: -

- If qualifying examination is passed from Delhi and Reservation certificate issued from Delhi for SC/ST/OBC categories, then admission is permissible under NCT Reserved category.
- If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
- If qualifying examination is passed from Delhi and Reservation certificate issued from Outside Delhi for SC/ST/OBC categories, then admission is permissible only under NCT Unreserved category.

7. **The candidature of all applicants in the entire admission process is “PURELY PROVISIONAL” pending scrutiny of eligibility as mentioned in the Admission Brochure 2022-23 for the programme.** In case, it is found at any stage of admission that the applicant does not fulfill the eligibility criteria and any information/document provided by the applicant is found to be false or is not in conformity with the eligibility criteria mentioned in the Admission Brochure 2022-23 including Age, Caste Category, Sub-Category, Educational Qualification, etc. the candidature of such applicant will summarily be rejected at any stage of admission process and even after admission.
8. **It is extremely important that applicants pay the fee within the time frame allocated, failing which it will be concluded that the applicant is not interested in the programme applied and the admission will be automatically cancelled.**
9. The physical document verification of documents by the applicant must be completed within the stipulated time interval as detailed on page 1 of this document, failing which you will lose your opportunity for admissions in the Dr B.R. Ambedkar University Delhi.
