13. Reservation Category/Caste Certificate (ST/ST/Delhi OBC) (wherever applicable). For requirement of SC/ST/certificates, please refer admission brochure. Only OBC Non Creamy Layer certificates issued after 31.03.2023 by the Competent Authority of NCT of Delhi will be accepted. 14. Medical Certificate (Please refer Annexure 7 of Admission brochure)
15. Anti-ragging affidavit. All applicants are required to submit a signed affidavit as detailed in the Admission brochure. (Please refer Annexure 8 and 8A of Admission brochure)
16. Applicant availing seats under CW/Defence/Differently Abled Person (PwBD)/Single Girl Child/Kashmiri Migrant/CCA/Sports have to carry relevant documents/certificate issued by competent authority. Please refer Annexure of Admission brochure for more details.
17. Latest income certificate for availing fee waiver as per University policy.
18. Information regarding orientation will be shared with the admitted students on their registered email ids.

Note: - The name of the applicant on the certificates claiming reservation must match with the applicant's name in their corresponding qualifying certificates and in CUET (PG)-2023. Similarly, parents' name should also match in the certificates. No undertaking on behalf of incomplete/invalid/non availability of document/certificate will be accepted.

**General Instructions:**

The applicants whose names are given in the provisional list, as below in the order of merit are hereby called for admission for the session 2023-24. The merit (System Based) has been calculated on CUET PG Scores on the basis of Paper Code considered by the University for the programme and eligibility as detailed on the website <https://aud.ac.in/uploads/4/admission/admission-2023/admission-brochure-2023-24.pdf>. The graduation marks will be verified for the basic eligibility for the programme before provisionally admitting the applicant.

Note:

1. The list is provisional as prepared on the basis of the CUET PG scores received from the National Testing Agency and application form submitted online on the University website by the applicants.
2. The provisional list for horizontal reserved seats (i.e. Defence, PwBD) and supernumerary seats will be announced separately.
3. Calling of the applicants for online document verification shall not be construed as entitlement for admission. Greater numbers of applicants than the seats available have been called to ensure that seats do not remain vacant. In case, an applicant fails to produce the requisite documents within stipulated time limit of relevant merit list as detailed on page no.-1, the seat will be offered to the next applicant in the merit list as per his/ her eligible category.
4. Applicants called as per the first merit list, who fail to provide the requisite documents for online verification within the prescribed time limit as mentioned on p.no-1 will not be considered in the subsequent list. However, they may be considered for admission later, during SPOT round, if any, the dates for which will be notified later, on the University Website. The admission during SPOT round shall be subject to the availability of seats in respective category to which the applicant had initially registered/applied and further submission of mandatory updated documents as per eligibility criteria mentioned in Admission Brochure 2023-24.
5. It will be the responsibility of the applicant to rectify the discrepancy within the prescribed time limits as per Admission Calendar Schedule. No claim for admissions, whatsoever, will lie on AUD, if applicant fail to upload the requisite documents within prescribed time.
6. The applicant will be admitted to the programme on the basis of the merit list prepared taking into consideration the CUET PG Scores on the basis of Paper Code considered by the University for the programme and eligibility criteria and availability of seats in each programme.

The dates of online document verification are liable to change. Therefore, all applicants are advised to check the University website regularly after declaration of merit lists for any unforeseen change in schedule. The candidature of all applicants in the entire admission process is "PURELY PROVISIONAL" pending scrutiny of eligibility as mentioned in the Admission Brochure 2023-24 for the programme.



7. Applicants in their own interest who have uploaded reservation certificates for availing reservation benefits (SC/ST/OBC/Defence/EWS/SGC/KM/PwBD) at the time of registration at University portal are requested to check the Admission brochure 2023-24 uploaded on the website for ascertaining the category to be considered as per the reservation policy.

Admissions under Reserved Category:

Clarification for Admissions under Reserved Category: Admission will be permissible to qualified applicants in any programme in the following conditions: -

- If qualifying examination is passed from Delhi and Reservation certificate issued from Delhi for SC/ST/OBC categories, then admission is permissible under NCT Reserved category.
 - If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
 - If qualifying examination is passed from Delhi and Reservation certificate issued from Outside Delhi for SC/ST/OBC categories, then admission is permissible only under NCT Unreserved category.
8. If two or more applicants have the same CUET PG Score, the marks in percentage of the qualifying degree (i.e. UG Degree) upto two decimal will be counted as the tie-breaker. If the UG marks in percentage is still tied, the older applicant will be given the admission.
9. Transfer case may be accepted from one programme to another programme. For such applicants (who want to take transfer), they must fill the transfer form available at Annexure-12 in the Admission Brochure 2023-24 and submit it to pgverification@aud.ac.in.
10. **The candidature of all applicants in the entire admission process is “PURELY PROVISIONAL” pending scrutiny of eligibility as mentioned in the Admission Brochure 2023-24 for the programme.** In case, it is found at any stage of admission that the applicant does not fulfill the eligibility criteria and any information/document provided by the applicant is found to be false or is not in conformity with the eligibility criteria mentioned in the Admission Brochure 2023-24 including Age, Caste Category, Sub-Category, Educational Qualification, etc. the candidature of such applicant will summarily be rejected at any stage of admission process and even after admission.
