(b) Those applicants, against which discrepancy/remarks has been mentioned, needs to get the discrepancy removed by 17th September 2023 (till 4 PM) by sending their requisite documents at pgverification@aud.ac.in positively. 13. Reservation Category/Caste Certificate (ST/ST/Delhi OBC) (wherever applicable). For requirement of SC/ST/certificates, please refer admission brochure. Only OBC Non Creamy Layer certificates issued after 31.03.2023 by the Competent Authority of NCT of Delhi will be accepted. 14. Medical Certificate (Please refer Annexure 7 of Admission brochure)

16. Applicant availing seats under CW/Defence/Differently Abled Person (PwBD)/Single Girl Child/Kashmiri Migrant/CCA/Sports have to carry relevant documents/certificate issued by competent authority. Please refer Annexure of Admission brochure for more details.
17. Latest income certificate for availing fee waiver as per University policy.
18. Information regarding orientation will be shared with the admitted students in their registered email ids.

Note: - The name of the applicant on the certificates claiming reservation must match with the applicant's name in their corresponding qualifying certificates and in CUET (PG)-2023. Similarly, parents' name should also match in the certificates. No undertaking on behalf of incomplete/invalid/non availability of document/certificate will be accepted.

**General Instructions:**

The applicants whose names are given in the provisional list, as below in the order of merit are hereby called for admission for the session 2023-24. The merit (System Based) has been calculated on CUET PG Scores on the basis of Paper Code considered by the University for the programme and eligibility as detailed on the website <https://aud.ac.in/uploads/4/admission/admission-2023/admission-brochure-2023-24.pdf>. The graduation marks will be verified for the basic eligibility for the programme before provisionally admitting the applicant.

Note:

1. The list is provisional as prepared on the basis of the CUET PG scores and first priority has been given to the already registered applicants on the University website and shown the interest. If seat(s) still remain vacant, second priority has been given to the fresh applicants
2. Calling of the applicants for online document verification shall not be construed as entitlement for admission. Greater numbers of applicants than the seats available have been called to ensure that seats do not remain vacant. In case, an applicant fails to produce the requisite documents within stipulated time limit of relevant merit list as detailed on page no.-1, the seat will be offered to the next applicant in the merit list as per his/ her eligible category.
3. It will be the responsibility of the applicant to rectify the discrepancy within the prescribed time limits as per Admission Calendar Schedule. No claim for admissions, whatsoever, will lie on AUD, if applicant fail to upload the requisite documents within prescribed time.
4. Applicants in their own interest who have uploaded reservation certificates for availing reservation benefits (SC/ST/OBC/Defence/EWS/SGC/KM/PwBD) at the time of registration at University portal are requested to check the Admission brochure 2023-24 uploaded on the website for ascertaining the category to be considered as per the reservation policy.

Admissions under Reserved Category:

Clarification for Admissions under Reserved Category: Admission will be permissible to qualified applicants in any programme in the following conditions: -

- If qualifying examination is passed from Delhi and Reservation certificate issued from Delhi for SC/ST/OBC categories, then admission is permissible under NCT Reserved category.
- If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
- If qualifying examination is passed from Delhi and Reservation certificate issued from
