The applicants whose names are given in the provisional list, as below in the order of merit are hereby called for admission for the session 2023-24. The merit (System Based) has been calculated on CUET PG Scores on the basis of Paper Code considered by the University for the programme and eligibility as detailed on the website

Note:

- 1. The list is provisional as prepared on the basis of the CUET PG scores and first priority has been given to the already registered applicants on the University website and shown the interest. If seat(s) still remain vacant, second priority has been given to the fresh applicants
- 2. Calling of the applicants for online document verification shall not be construed as entitlement for admission. Greater numbers of applicants than the seats available have been called to ensure that seats do not remain vacant. - If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
