Payment Link will be provided to the applicant. Applicants need to pay the fee by logging into their user ID and password, which will remain valid till 5.00PM of the day of verification of documents. A copy of the payment receipt need to be submitted at the admission counter after the payment. The University has made arrangement of computer facility with internet support and printer at the admission venue to facilitate the applicants without any charges.</i></p> <p><i>It is strongly desired that the applicants need to visit the campus for physical verification of documents by bringing original documents as listed below along with <u>a set of self-attested photocopy of the documents and account details for payment of fees.</u></i></p>

Immediately after the physical verification of documents, the applicants are required to pay the required fee through admission portal only on 7th and 8th Aug. 2023 as the case may be. Also an email for payment of fee will be sent on registered email filled by the applicant at the time of registration. 3. <i>Applicants eligible for admission in more than one programme, can take admission in one programme only. 3. Copy of the CUET Application form.
4. Copy of AUD Application form.
5. Copy of the CUET Score Card.
6. Domicile certificate / Address proof / Passport copy / Voter card
7. Aadhaar card (optional)
8. Certificate of qualifying exam (class XII)
9. Certificate of class X (For verification of Date of Birth)
10. Migration Certificate/School Leaving Certificate
11. EWS certificate issued by the competent authority as notified by Govt. of India (for those who have applied under EWS), if applicable.
12. Reservation Category/Caste Certificate (ST/ST/Delhi OBC) (wherever applicable). For requirement of SC/ST/certificates, please refer admission brochure. Only OBC non creamy layer certificates issued after 31.03.2023 by the Competent Authority of NCT of Delhi will be accepted. 13. Applicant availing seats under CW/Defence/Differently Abled Person (PwBD)/Single Girl Child/Kashmiri Migrant/CCA/Sports have to carry relevant documents/certificate issued by competent authority. Please refer Annexure of Admission brochure for more details.

Documents to be submitted after confirmation of Admission during the school level orientation:

1. Medical Certificate (Please refer Annexure 7 of Admission brochure)
2. Anti-ragging affidavit. All applicants are required to submit a signed affidavit as detailed in the Admission brochure. (Please refer Annexure 8 and 8A of Admission brochure)
3. Latest income certificate for availing fee waiver as per University policy.

The applicant must submit the physical documents during the orientation to School Office, failing which



you will lose your opportunity for admissions in the Dr B.R. Ambedkar University Delhi.

Note: - The name of the applicant on the certificates claiming reservation must match with the applicant's name in their corresponding qualifying certificates and in CUET (UG)-2023. Similarly, parents' name should also match in the certificates. No undertaking on behalf of incomplete/invalid/non availability of document/certificate will be accepted.

**General Instructions:**

The applicants whose names are given in the provisional list, as below in the order of merit are hereby called for admission for the session 2023-24. The merit (System Based) has been calculated on normalised CUET score for the programme and eligibility as detailed on the website <https://aud.ac.in/uploads/4/admission/admission-2023/admission-brochure-2023-24.pdf> The class XII marks will be verified for the basic eligibility for the programme before provisionally admitting the applicant.

Note:

- 1. It is mandatory for the applicant to report the Admission Desk for Physical Verification of documents and payment of fees as per the dates and time given above.**
- The list is provisional as prepared on the basis of the normalised CUET scores received from the National Testing Agency (NTA) and application form submitted online on the University website by the applicants.
- The provisional list for horizontal reserved seats (i.e. Defence, PwBD) and supernumerary seats will be announced separately.
- Calling of the applicants for physical verification of documents shall not be construed as entitlement for admission. Greater numbers of applicants than the seats available have been called to ensure that seats do not remain vacant. In case, an applicant fails to produce the requisite documents within stipulated time limit of relevant merit list as detailed on page no.-1, the seat will be offered to the next applicant in the merit list as per his/ her eligible category.**
- Applicants called as per the first merit list, who fail to provide the requisite documents in person for physical verification within the prescribed time limit as mentioned on p.no-1 will not be considered in the subsequent list.** However, they may be considered for admission later, during SPOT round, if seats remain vacant, the dates for which will be notified later, on the University Website. The admission during SPOT round shall be subject to the availability of seats in respective category to which the applicant had initially registered/applied and further submission of mandatory updated documents as per eligibility criteria mentioned in Admission Brochure 2023-24.
- It will be the responsibility of the applicant to rectify the discrepancy within the prescribed time limits as per Admission Calendar Schedule. No claim for admissions, whatsoever, will lie on AUD, if applicant fail to upload the requisite documents within prescribed time and submits for physical verification in person.**
- The applicant will be admitted to the programme on the basis of the merit list prepared taking into consideration the normalised CUET Scores for the programme and eligibility criteria and availability of seats in each programme.
- Applicants in their own interest who have uploaded reservation certificates for availing reservation benefits (SC/ST/OBC/Defence/EWS/SGC/KM/PwBD) at the time of registration at University portal are requested to check the Admission brochure 2023-24 uploaded on the website for ascertaining the



category to be considered as per the reservation policy.

Admissions under Reserved Category:

Clarification for Admissions under Reserved Category: Admission will be permissible to qualified applicants in any programme in the following conditions: -

- If qualifying examination is passed from Delhi and Reservation certificate issued from Delhi for SC/ST/OBC categories, then admission is permissible under NCT Reserved category.
- If qualifying examination is passed from Outside Delhi and Reservation certificate issued from anywhere in India, including Delhi for SC/ST categories, then admission is permissible under ONCT Reserved category.
- If qualifying examination is passed from Delhi and Reservation certificate issued from Outside Delhi for SC/ST/OBC categories, then admission is permissible only under NCT Unreserved category.

9. **The candidature of all applicants in the entire admission process is “PURELY PROVISIONAL” pending scrutiny of eligibility as mentioned in the Admission Brochure 2023-24 for the programme.** In case, it is found at any stage of admission that the applicant does not fulfil the eligibility criteria and any information/document provided by the applicant is found to be false or is not in conformity with the eligibility criteria mentioned in the Admission Brochure 2023-24 including Age, Caste Category, Sub-Category, Educational Qualification, etc. the candidature of such applicant will summarily be rejected at any stage of admission process and even after admission.
10. **It is extremely important that applicants pay the fee within the time frame allocated, failing which it will be concluded that the applicant is not interested in the programme applied and the admission will be automatically cancelled.**
