



## NOTIFICATION

Consequent upon the declaration of results of the election for Committee for Prevention of Sexual Harassment (CPSH) held on 10 October 2018, the CPSH Committee is re-constituted under the provision of the Policy on Prevention, Prohibition and Redressal of Sexual Harassment and Discrimination based on Gender Identity and Sexual Orientation, as approved by the BoM in its 16<sup>th</sup> Meeting and notified by the University on 19.9.2014, as under:

2. The term of the student members of the CPSH shall be one year from the date of election or till the expiry of the term of their Studies/residence in hostel in AUD as the case may be whichever is earlier under the respective category.

3. Similarly the term of teaching, academic and non-teaching staff members who are presently working on contract/temporary capacity, shall not exceed their engagement in AUD.

4. There shall be a common Chairperson of CPSH for Kashmere Gate, Karampura and Lodhi Road campuses under clause 3.6 of the Policy as notified by the University.
